## BUYER / SELLER & HEALTH CONTRACT:

Carol's Corgis (owned and operated by Carol Williams) hereby referred to as the BREEDER, on (date) \_\_\_\_\_, sold one (1) AKC registered Pembroke Welsh Corgi puppy (features listed below) hereby referred to as DOG for the sum of (sum) \$\_\_\_\_\_ to (first name/last name) \_\_\_\_\_ hereby known as the BUYER. The BREEDER guarantees this DOG to be free of any congenital defects for one (1) year from the date of purchase. If, within the one year guarantee the DOG is found and certified by a licensed veterinarian to have a congenital disorder which adversely affects the health of the animal and if the BREEDER is notified within two (2) business days of the veterinarians determinations, the BREEDER will provide a replacement DOG for equal value of the original purchase. However, the BREEDER will not be responsible for veterinarian fees, shipping costs and other costs associated with replacement.

The BREEDER guarantees that the above said DOG is a purebred Pembroke Welsh Corgi, registered with the American Kennel Club, and that a registration application, true copy of its pedigree and a health certificate shall be given to the BUYER at the time of purchase.

The BREEDER guarantees that the DOG be free of all communicable disease(s) for two (2) days from the date of purchase stated on this record. The BREEDER will not be responsible for any medial expenses incurred. This guarantee does not include coccidian and kennel cough, allergies, thyroid dysfunction, demodectic mange, and other autoimmune disorders that are not covered by this guarantee. Any physical problem, which is or could be the result of injury, is not covered by this guarantee. There is no guarantee that the BUYER will be able to show or breed the DOG. The DOG is vet checked and current on worming and vaccinations as are all DOG(s) produced by the BREEDER. All deposits are non-refundable; however, they are transferable toward another puppy at any time in the future as long as the BREEDER continues to breed and raise Pembroke Welsh Corgis.

The BUYER agrees to give this DOG loving care, proper veterinary care, and proper training throughout its lifetime. This DOG will be given adequate and proper shade and housing and be properly and sufficiently fed. This DOG shall not be neglected in any manner and in no way mistreated.

The BUYER guarantees the BREEDER right of first refusal if the DOG is to be sold or disposed of in any way. If the BREEDER does not wish to acquire the DOG, the BREEDER will assist the BUYER in placing him.

The BREEDER has the right to revoke this written agreement before the DOG is placed with new owners at any time for any reason.

The above agreement is made and signed by both parties to assure the well-being and protection of this animal. No part of this contract is transferable.
